ATTENTION!INSTALLER NOTE:

stereo, turn ON and adjust to 1/2 VOLUME level to prevent low volume output AFTER installation.

PRELIMINARY

BEFORE BEGINNING: READ THIS ENTIRE INSTRUCTION MANUAL FIRST.

CAUTION: Disconnect Negative Battery Terminal to avoid short circuits. Read ALL manufacturers warnings regarding air bags and electrical systems in your vehicle. We recommend the use of a volt/ohm meter or computer-safe LED probe when checking wiring. A testlight or grounded light probe if used improperly can cause damage to the vehicle's computer and/or diagnostic system.

This interface is designed to work with an aftermarket radio's equipped with "front" and "rear" pre-amp (RCA) outputs. If your radio only has one set of outputs, then you must use "Y" splitters. As a result there will be NO fade control.

FADER CONTROL NOTE!


Keep the stereo's volume at HALF level when adjusting the front/rear fader: At lower volume levels, JBL Synthesis Systems may not completely fade out 100% of the audio on front or rear [depending on your desired adjustment] due to factory DSP processing.

INSTALLATION

- Disconnect the Negative battery cable from the battery to avoid any short circuits.
- Remove and unplug factory stereo. If needed, call Scosche Tech Support (800) 621-3695 x3 for stereo removal steps specific to your vehicle.
- 3. Match and connect the appropriate wires from the TA07SR harness to the appropriate wires of the plug provided with your aftermarket stereo. For example, connect the +12V "yellow" constant lead from your stereo to the "yellow" wire on the TA07SR harness. The color codes are designed to match MOST brands of aftermarket car stereo. For STD JBL and JBL SYSNTHESIS systems, USE RCA line outputs from aftermarket stereo for speaker connections. For non-JBL/Premium Sound Systems please contact Scosche Tech Support for proper installation applications for your specific vehicle.
- 4. Tape all unused wires to prevent wires from short circuiting.
- 5. Reconnect the negative battery cable
- 6. Connect the 20-Pin TA07SR connector to the factory harness.
- As you install your new stereo, place the TA07SR module in the rear of the dash cavity behind the stereo. (Optional: Cable ties or double sided tape can be used to secure the module, but are not included).

WIRE COLOR CODES

White RCA Left front channel input Green RCA Left rear channel input Violet RCA Right rear channel input Gray RCA Right front channel input = Black Chassis ground (-12V) = Yellow +12 volt battery constant Orange +12 volt illumination =

Orange/Black = Dimmer

Red = +12 volt ignition switched

Blue/White = +12 volt remote output (amp remote, radio ON signal)

Blue = +12 volt power ant. or ant. amplifier

The color codes used on this car stereo connector conform to the standards set by the E.I.A. (Electronics Industry Association). They may differ from the wiring codes found on your specific car stereo. Always refer to your stereo owners manual for wiring details about your particular car stereo.

TROUBLESHOOTING		
PROBLEM	TIP/SOLUTION	
Vehicle does not recognize the interface	It is recommended to turn "ON" the ignition key to the "RUN" position for approximately 2 seconds and "OFF" twice before beginning the first test of the newly installed interface	
LED does not turn on	It is recommended to check "ALL" wiring connections and also ensure that the power wires are getting their proper +12 volts	
Low volume with aftermarket radio	Re-install factory radio, turn on and adjust to 1/2 volume


FIGURE 2 Important!! TA07SR 24-pin connection

No audio	Possible non-digital JBL system. See Fig. 2	
Intermittent audio, noise, fade or balance issues	Possible Molex connection problem. See Fig. 3

If you experience intermittent sound, engine noise and/or BAL/FAD issues, please check to ensure the 24-pin wire is firmly pressed in and snapped into place.
